## **Association Reports**

## **ATA Local Report**

The Board received for information the Alberta Teachers' Association (ATA) Local No. 28 report from President Deneen Zielke:

- On February 7, the ATA hosted a Partners in Education Luncheon featuring keynote speaker Candy Palmater, a Canadian comedian and broadcaster. Zielke thanked Chair Boymook and trustees Don Irwin and Stadnick for attending. She also thanked executive members from EIPS' Committee of School Councils, Jacquie Surgenor and Lesley Bowman.
- The ATA obtained documents from a request under the *Freedom of Information and Protection and Privacy Act*. The documents show, despite government assurances of a funding freeze, school boards received \$136 million less in 2019-20 than in the 2018-19 school year. The Local is disheartened and hopes more public pressure will convince the government to fund education in the upcoming year adequately.

## **Student Transportation Fee Structure**

The Board approved the 2020-21 Student Transportation Fee Structure, effective in the 2020-21 school year. The

new fee structure reflects recent changes made to Alberta Education's School Transportation Regulation AR 96/2019, which is guided by the *Education Act*. EIPS families using student transportation services will see the following fee changes starting in the 2020-21 school year:

- The introduction of a two-tiered fee structure—both <u>eligible</u> and <u>ineligible</u> riders will pay a fee for busing services. For some, fees will increase, and for others, fees will decrease.
- The elimination of the Student Transportation family rate.
- The elimination of an exemption for ineligible riders who cross or walk along a road with speeds limits of 60 kilometres per hour, or higher, without a sidewalk or standard traffic light protection (see <u>Policy 17: Student Transportation Services</u>, section 1.5).

## **New Business**

### Policy 17

The Board approved amendments to <u>Policy 17: Student Transportation</u> <u>Service</u>. The revisions align with the new 2020-21 Student Transportation Fee Structure.

### **Policy Committee**

The Board approved amendments to <u>Policy 7: Board Operations</u>. The revisions clarify how notification about special meetings is communicated.

### **Borrowing Resolution 2019-20**

The Board approved the Division's borrowing resolution to meet expenditures during the 2019-20 school year. Annually, the Division submits a borrowing resolution to the Bank of Montreal to support the credit-facility agreements in place.

## Canada Revenue Agency Corporate Information

The Board approved Candace Cole, the Secretary-Treasurer, and Carmine von Tettenborn, the Director of Financial Services, as the owners of the Division's online Canada Revenue Agency corporate business account. As owners, both individuals can access the account to review quarterly returns, file payroll-deduction remittances and receive correspondences with the Canada Revenue Agency.

## **Committee Reports**

#### Advocacy Committee

The Board received for information the report from the Advocacy Committee meeting on January 23. The committee reviewed the strategic advocacy plan for education funding; approved the plan's Strengths, Weaknesses, Opportunities and Threats analysis; and discussed strategies to share and raise awareness about the stories taking place within EIPS.

### **Policy Committee**

The Board received for information the report from the Policy Committee meeting on February 11. Members reviewed policies 8, 17, 20 and 21 and discussed a new draft policy about petitions and public notices.

Trustees shared information and highlighted recent events:

- *Trustee Randy Footz* attended several events, including school council meetings at A.L. Horton Elementary and Vegreville Composite High; a basketball tournament at Vegreville Composite High; and a tour of Heritage Hills Elementary.
