EIPS GOAL: Quality infrastructure for all.

EIPS OUTCOME: Learning and working environments are supported by effective planning,

management and investment in Division infrastructure.

ISSUE:

That the Board of Trustees receives for information the trustees' compensation schedule for the 2025-26 year.

BACKGROUND:

Per Section 12.3 of Policy 7: Board Operations:

Trustees' compensation shall be adjusted September 1 annually. The methodology to be used is an average of the per cent change in annual average index of Alberta Consumer Price Index (CPI) and the per cent change in annual average earnings Alberta Average Weekly Earnings (AWE) (not less than zero).

CURRENT SITUATION OR KEY POINT:

The Consumer Price Index (CPI) is a key measure of inflation that reflects changes in the prices paid by Canadian consumers for a consistent basket of goods and services over time. In June 2025, Alberta's CPI rose by 1.9% compared to the same month in 2024.

Alberta's Average Weekly Earnings (AWE) represent the total weekly earnings divided by the number of employees in the province. In May 2025, Alberta's average weekly earnings rose by 2.4% compared to May 2024. This increase reflects higher wages across various sectors and changes in employment composition.

The average of the percent change for the above two items is 2.2%. The annual compensation numbers will be reflected in the 2025-26 Fall Budget.
